What types of cookies are used on this website?

This website can use several types of cookies:

Deactivation of cookies.

You can allow, block or remove cookies installed on your computer by configuring the browser options installed on your computer. In a large majority of Web browsers, you have the possibility to allow, block or delete cookies installed on your computer. In the next few lines we will tell you how to access the configuration of the most frequent web browsers to accept, install or disable cookies:

Cookie settings in Google Chrome:

How to delete specific cookies or all cookies: You can erase source and third-party cookie information and data from your devices. If you remove cookies, you may also delete items such as preferences saved on websites

- On your computer, open Google Chrome.
- Click the three-point line in the upper right corner and then Settings.
- At the bottom, click Show advanced settings.
- In the "Privacy" section, click Content Settings.
- In the "Cookies" section, click on All cookies and all site data.
- To delete all cookies, click Delete all.
- To delete a specific cookie, select a site. On the right, click Close Close.
- If you wish, you can also remove all cookies created during a specific period. Allow or not allow cookies You can enable or disable cookies saved by websites.
- On your computer, open Google Chrome.
- Click the three-point line in the upper right corner and then Settings.
- At the bottom, click Show advanced settings.
- In the "Privacy" section, click Content Settings.

Use the "Cookies" section to change your settings:

- To allow source and third-party cookies, select Allow local data to be set.
- To block all cookies, select Block the data settings in the sites. When you use this setting, most of the sites you have to access do not work.
- To allow only source cookies and block all third-party cookies, check the box next to "Block site data and third-party cookies". This setting means that you can not write or read site data, even if you add a site to the exception list and choose to allow your cookies.

How can you verify that the settings have been saved

If you visit a site and if a cookie is blocked, you will see the icon of a blocked cookie in the address bar.

Configure cookies in Microsoft Internet Explorer:

To delete cookies

- In Internet Explorer, select the Tools button, navigate to Security and select Delete browsing history.
- Check the Cookies and data on the website check box and select Delete. To remove cookies in Internet Explorer 8
- In Internet Explorer, select the Security button and then Clear Browsing History.
- Check the box next to Cookies.
- Check the Keep favorite website data box if you do not want to delete the cookies associated with the websites in the Favorites list.
- Select Delete.

Block or allow cookies

If you do not want sites to store cookies on your computer, you can block cookies. However, by blocking cookies, some pages may not display correctly or a message may appear that tells you that cookies must be

enabled before you can view the site. By blocking cookies, it is also possible that some pages may not display properly or that a message will appear informing you that cookies must be enabled to view the site.

To block or allow cookies in Internet Explorer 11 for Windows 10

- In Internet Explorer, select the Tools button and then Internet Options.
- Select the Privacy tab and under Settings, select Advanced and choose whether to allow or block the origin and third party cookies or if you prefer to be asked. To block or allow cookies
- In Internet Explorer, select the Tools button and then Internet Options

Select the Privacy tab, and under Settings, move the slider all the way to the top to block all cookies (or to the end to allow them all) and select OK.

Configure cookies in Mozilla Firefox:

Open Firefox, click the browser menu in the top right corner (consisting of three bars) and select Options. And then go to Privacy > History.

In Firefox you can select Use a custom settings for the history and check the box Accept cookies.

If you want to make an exception for a site, click on the Exceptions button, enter the address of the site and click on Block.

Configure cookies in Safari (Apple).

Select Safari > Preferences, click Privacy and do any of the following:

Change what cookies and website data are accepted: Select the "Cookies and website data" option:

- Always block: Safari does not allow any website that visits, third parties or advertising to store cookies or other data on the Mac. This may prevent some websites from working properly.

- Allow only from the current website: Safari accepts cookies and data from websites only from the websites you are visiting at the moment. Normally websites have content integrated from other sources. Safari does not allow third parties to store or access cookies and other data.
- Allow from sites I visit: Safari accepts cookies and data from websites only from the websites you visit. Safari uses its existing cookies to determine if it has previously visited a website. Selecting this option helps prevent websites that have content integrated with other websites you visit from storing cookies and data on your Mac.
- Always allow: Safari allows all websites that visit, third parties and advertising to store cookies and other data on the Mac

Delete cookies and stored data:

click "Delete all data from websites" or under Details, select one or more websites and click Delete.

Deleting the data may reduce tracking, however, it may also mean that your sessions are closed on websites or your behavior changes.

See which websites store cookies or data: click Details.

Ask websites not to track you: some websites keep track of your browsing activities when they provide content, which gives them the ability to adapt what they offer. You can have Safari request sites and third-party content providers (including advertising) not to track you.

With this option enabled, whenever Safari obtains content from a website, it will request that it is not crawled, but it will depend on the website that this request is respected.
